Brief Invitational Rules

- All teams are guaranteed at least three games.
- Participation awards to all players in U8 and U10 age divisions.
- Individual awards for first and second place finishes in U12 through U19.
- All players must be registered with Iowa Soccer Association (ISA) affiliated teams and hold a current ISA ID.
- The Invitational Committee reserves the right to refuse any application and to make changes at any time.

Guest Player Allowance

Up to two ISA registered guest players will be allowed for teams that may not have enough players and otherwise could not enter the Invitational. This allowance is not intended so that coaches can exclude available players in favor of guest players. The Invitational Committee will determine the eligibility of guest players.
