



# OFFICIAL RULES

Mahaska County Soccer Club  
 Mahaska Cup 2019  
 Oskaloosa, Iowa  
 June 1 & 2, 2019

**1. Laws of the Game**

A. All games will be played in accordance with the laws of game as written by FIFA and The Iowa Soccer Association (ISA) except as noted below.

**2. Team Participation**

A. All participating teams must be currently registered and in good standing with the ISA.

**3. Entry Fees – All Checks should be made out to Mahaska County Soccer Club**

8/9U (4 v 4) \$100  
 10/11U (7 v 7) \$150  
 12/13U (9 v 9) \$175  
 14/15U (11 v 11) \$210

**4. Player Eligibility**

- A. A player may play for only one team in the Invitational. Players must be on the team’s submitted Invitational roster in order to participate. No roster changes will be made during the Invitational. Any violation of this rule will result in forfeit of all Invitational games.
- B. A limit of three (3) guest players will be allowed for teams that may not have enough rostered players and otherwise could not enter the Invitational. Teams utilizing guest players will submit the Guest Player Form at the same time as the Team rosters. No guest players will be accepted the day of the Invitational. A guest player is defined as an ISA registered recreational player from a team that is not participating in the Invitational. The use of guest players is not intended so that coaches can exclude available rostered players in favor of the guest players.
- C. A valid signed ISA membership card with attached photo is mandatory for all players including guest players.
- D. Only recreational teams will be allowed to play in the Invitational. A recreational team is defined as a team that participates in a recognized recreational league.

**5. Team Composition**

A. Goalkeepers will be allowed for all 9/10U and older games. Offside will be called in all 10/11U and older games. Team rosters shall be limited as follows:

Age bracket	Maximum number of rostered players	Game Format	Minimum number of rostered players needed to field a team
8/9U	6	4 v 4	4
10/11U	12	7 v 7	6
12/13U	16	9 v 9	8
14/15U	18	11 v 11	11



## 6. Registration

- A. All teams, including all players and coaches, must check in at the Invitational Registration Tent no later than 45 minutes prior to the team's first game. All players will receive a hand stamp once they have been properly registered.
- B. At check in all teams will be asked to present the following for each player:
  - 1. Official Roster with all rostered players and guest players on it
  - 2. A valid signed ISA membership card with attached photo.
  - 3. A signed medical consent form.

## 7. Equipment

- A. All player equipment shall be in accordance with the laws of the game as amended for youth.
- B. All player equipment is subject to referee approval.
- C. The center referee shall have final authority on any equipment issues.
- D. Teams should be prepared to provide an additional uniform or penny of a contrasting color as required by the center referee. Secondary uniforms may be numberless and should only be worn if there is a color conflict.
- E. Uniform jerseys must be tucked in and shin guards must be covered with socks.

## 8. Match Information

- A. Teams will report to their designated field at least 15 minutes prior to start of each match.
- B. Prior to each match the center referee or other designated official will check players for hand stamps and proper equipment. Any player missing a hand stamp will NOT be allowed to play until they have visited the registration tent, been properly checked in and received a stamp. Any player missing required equipment will not be allowed to play until the center referee is satisfied that the proper equipment has been secured.
- C. No jewelry of any kind will be permitted.
- D. Players with a hand or arm cast will cover the cast with a suitable safe material. The center referee must inspect and approve this covering before each game. Bubble wrap is a suggested suitable material.
- E. A match will be considered forfeit if a team
  - 1. is more that 5 minutes late for a scheduled match.
  - 2. refused to field a team when the referee indicates that the match is to begin.
  - 3. does not have enough players present to field a team when the referee indicates that the match is to begin.
  - 4. if a team quits a match before its conclusion.
- F. If the center referee determines that there is a conflict with the teams' uniform colors the home team, as determined by the Invitational bracket, will change jerseys.

## 9. Length of Match and Ball Size

- A. Match length, ball size and halftime interval will be as follows:

Age bracket	Match length	Ball size	Halftime interval
7/8U	4 x 8 min quarters	3	5 minutes
9/10U	2 halves of 20 minutes	4	5 minutes
11/12U	2 halves of 25 minutes	4	5 minutes
14/15U	2 halves of 35 minutes	5	10 minutes
16/19U	2 halves of 35 minutes	5	10 minutes

- B. All matches will start and end on time. No overtime or additional time will be allowed.
- C. In case of inclement weather or darkness, the Invitational Director shall decide the official outcome of each affected match.



## **10. Invitational Scoring**

- A. Division standings for age groups 11/12U and up will be decided by the following point system.  
Teams with the most points in each division will advance to play in the championship rounds.
- B. If a wild card is necessary, the wild card team will be the next team with the most points regardless of the group.

Win = 3 points; Tie = 1 point; Loss = 0 points; Red card = -2 points

## **11. Tie Breaker Criteria**

- A. In the event of a tie in the Invitational scoring the following procedure will be used to determine the winner.
  - 1. Team without a suspended player
  - 2. Head to Head (not used if more than two teams are involved)
  - 3. Goal Spread, total goals scored minus goals allowed
  - 4. Fewest Goals allowed
  - 5. Most goals scored
  - 6. Coin toss by the Invitational Director

## **12. Final Match**

- A. In the event of a tie of a division semi-final or final match a shoot out will be used to determine the winner.
- B. Shoot out procedure is as follows:
  - 1. Each team will select five players to kick
  - 2. Only players on the field at the end of the game may be selected
  - 3. Teams will alternate kicks (first to kick is determined by referee coin toss)
  - 4. If score remains tied after 5 kicks, the team will alternate kicks using five new players until a winner is determined.
  - 5. Goalkeepers may be changed after each shot from available players on the field.

## **13. Substitutions**

- A. Substitutions shall be unlimited and may be made with the consent of the referee at the following times:
  - 1. Prior to a throw in your favor or in conjunction with substitution by other team.
  - 2. Prior to a goal kick by either team.
  - 3. After a goal by either team.
  - 4. At the halftime interval.
  - 5. For an injured player. The opposing team may also substitute at this time.
- B. Any player issued a caution (yellow card) must be substituted during the stoppage in play. The opposing team may also substitute at this time. The cautioned player may re-enter field at the next substitution opportunity.

## **14. Ejection**

- A. Two cautions (yellow cards) in the same match shall be considered a sending off offense (red card) and will result in the suspension of that player from the match being played.
- B. Any player that is sent off will be suspended for the remainder of the match, and the next match.
- C. For safety reasons any suspended player will remain seated quietly in their team's technical area until the conclusion of the match.
- D. A suspended player and their coach must report to the invitational registration tent immediately after the game in which the suspension was given to determine the player's status for subsequent games.



- E. Any coach that is sent off will immediately make arrangements to have a substitute coach by either using an assistant coach or a parent. They will then immediately proceed to the invitational registration tent and wait there until the center referee arrives to determine the coach's status for subsequent games.

## **15. Teams**

- A. Coaches are responsible for the conduct of their players at all times.
- B. The referee has the authority to verbally warn, caution or send off any players or coach.
- C. Every team is requested to insure that the field and surroundings are clean and litter free.
- D. Alcohol or illicit drugs in any form will not be allowed on any playing field or areas within the complex. Possession will result in immediate removal from the soccer complex.
- E. Pets will not be permitted on the complex at any time.
- F. Smoking will not be permitted on the complex at any time.

## **16. Spectators**

- A. Spectators shall be seated on the opposite side of the field from the team's technical areas and shall not stand or sit behind the goal.
- B. Abusive language and actions towards the officials or team members of either side will not be tolerated.
- C. The referee has the authority to verbally warn, caution or eject any disruptive spectators.
- D. All spectators are requested to insure that the field and surroundings are clean and litter free.
- E. Alcohol or illicit drugs in any form will not be allowed on any playing field or areas within the complex. Possession will result in immediate removal from the soccer complex.
- F. Pets will not be permitted on the complex at any time.
- G. Smoking will not be permitted on the complex at any time.

## **17. Cancellations**

- A. If the Invitational is cancelled due to weather or other uncontrollable situation before the Invitational starts a refund of the entry fee minus 20%, for administrative costs, will be sent to each registered team.
- B. If any matches are cancelled or shortened due to inclement weather, darkness or other uncontrollable situation after the invitational starts there will be no refunds of invitational entry fees. Every possible effort will be made to ensure all games are played. Teams will be expected to play regardless of conditions based on the decision of the Invitational Committee.
- C. The Invitational Committee shall have the authority to:
  - 1. End games after completion of the first half and record scores at that time.
  - 2. Reschedule or relocate games.
  - 3. Shorten match time up to 50%.
  - 4. Cancel any games in the preliminary round that have no bearing on the Invitational outcome.
  - 5. Cancel all or part of the Invitational without penalty.

## **18. Protests**

- A. The Invitational Committee will not authorize or accept any protest. All decisions of the match referees are binding on all parties and games will stand as played.

## **19. General**

- A. Each player and Coach is participating at her/his own risk.
- B. Referees will report scores to the Invitational Registration Tent following each game.
- C. Official standings will be posted at the Invitational Director's Table. It is each coach's responsibility to check these standings to determine accuracy of results and scheduling of final rounds.



## **20. Invitational Committee**

- A. The Invitational Committee consists of the Invitational Director (Board President), Director of Referees, and Director of Fields. All decisions of the Invitational Committee relating to the Invitational are final and binding on all parties.
